YOU MAY NOT ENTER THE POOL AREA WITHOUT A PASS!

POOL PASSES CAN ONLY BE ISSUED IF THE HOMEOWNER IS CURRENT ON THEIR ASSOCIATION FEES AND HAVE NO ARCHITECTURAL VIOLATIONS ON THEIR UNIT.

PLEASE SUBMIT A COMPLETED INFORMATION SHEET ALONG WITH A SMALL RECENT PICTURE OF EACH FAMILY MEMBER THAT YOU ARE REQUESTING A POOL PASS FOR. PICTURES MUST HAVE BEEN TAKEN WITHIN THE LAST 3 YEARS FOR ADULT AND 2 YEARS FOR CHILDREN. DIGITAL PICTURES CAN BE SUBMITTED. CHILDREN STARTING AT AGE FIVE ARE REQUIRED TO HAVE A POOL PASS. Please make sure a name is on the back of each picture.

POOL PASSES WILL ONLY BE ISSUED TO UNIT OWNERS AND FAMILY THAT LIVE IN THE UNIT. ANY FALSE INFORMATION ON THE POOL INFORMATION SHEET WILL RESULT IN THE WHOLE UNIT LOSING THEIR POOL PASSES FOR THE REST OF THE POOL SEASON. YOU MAY BE ASKED TO VERIFY THE INFORMATION YOU HAVE PROVIDED ON THE POOL INFORMATION SHEET.
